## REACH PARTNERS WITH THREE COUNTIES ON RURAL HEALTH CARE INITIATIVE

MERRIAM, KANSAS – The REACH Healthcare Foundation has announced a new partnership with three rural counties to address gaps in health care access and quality. The REACH Foundation is supporting community-based planning activities in Cass and Lafayette counties in Missouri, and Allen County, Kansas, as a first step toward identifying solutions to improve health care for uninsured and medically underserved people in rural communities.

Cass, Lafayette and Allen counties are part of the foundation's six-county service area. REACH is providing planning grants and access to research and consultation to help leaders in each county address health care challenges in their communities.

"With this initiative, the foundation is taking a different approach from our usual funding process by investing in county leadership so residents have the knowledge and tools to make improvements in their health care systems," said William Moore, Vice President of Programs, Policy and Evaluation.

Moore said the foundation has funded health programs in the counties over several years, but has not seen significant changes in health disparities between rural and urban areas. Moore said the foundation is investing in each community's capacity to propose solutions for ensuring equal access to high-quality, affordable health care.

To launch the Rural Health Initiative, the foundation sponsored planning teams from Allen, Cass and Lafayette counties to attend the National Rural Health Association Summit in Denver in April 2012. The foundation will connect county leaders with rural health program experts from other parts of the country and models for implementing and sustaining community change. The foundation expects to invest grant dollars beginning in 2013 to support proposals that result from the planning processes.

National and regional data show that access to primary medical care, oral health care and mental health services is more limited in rural communities. County health rankings for Cass, Lafayette and Allen counties show higher rates of preventable hospital stays, and lower rates of diabetic screenings and mammography. Life expectancy is lower in two of the three counties than the national average. Premature death in the three counties is also higher than the national average. For example, Allen County, Kansas, exceeded the national benchmark by more than 200 percent.

The three counties have been part of the foundation's service area since its beginnings. Moore said the challenge for REACH in investing in rural areas is the concentration of population and services in a few communities and the limited number of nonprofit health and human service organizations. Moore said the focus on developing county-wide networks offers the potential to bring in new voices for how counties can improve health services for uninsured and medically underserved residents.
